Pursuant to Rule 305.e. (1). B. Advance Notice, of the Rules and Regulations of the Colorado Oil and Gas Conservation Commission ("COGCC"), Unioil, a wholly owned subsidiary of Petroleum Development Corporation, Inc., ("PDC"), as Operator, hereby gives notice to you that it intends to commence operations for the drilling of a well or wells for oil/and or gas on the referenced lands no sooner than (30 days). As surface owner you have the responsibility for notifying any affected tenant of the proposed operations.

This well location has been staked (surveyed) and we had our Consultation meeting on March 27, 2008, concerning this location. The original drilling permit expired June 29, 2009, and we will be re-filing the drilling permit with the State.

The attached two (2) page site diagram depicts the proposed location of the well and associated roads and production facilities. At this time, PDC expects that the expected date of commencement of operations with heavy equipment will be in mid October of 2009.
