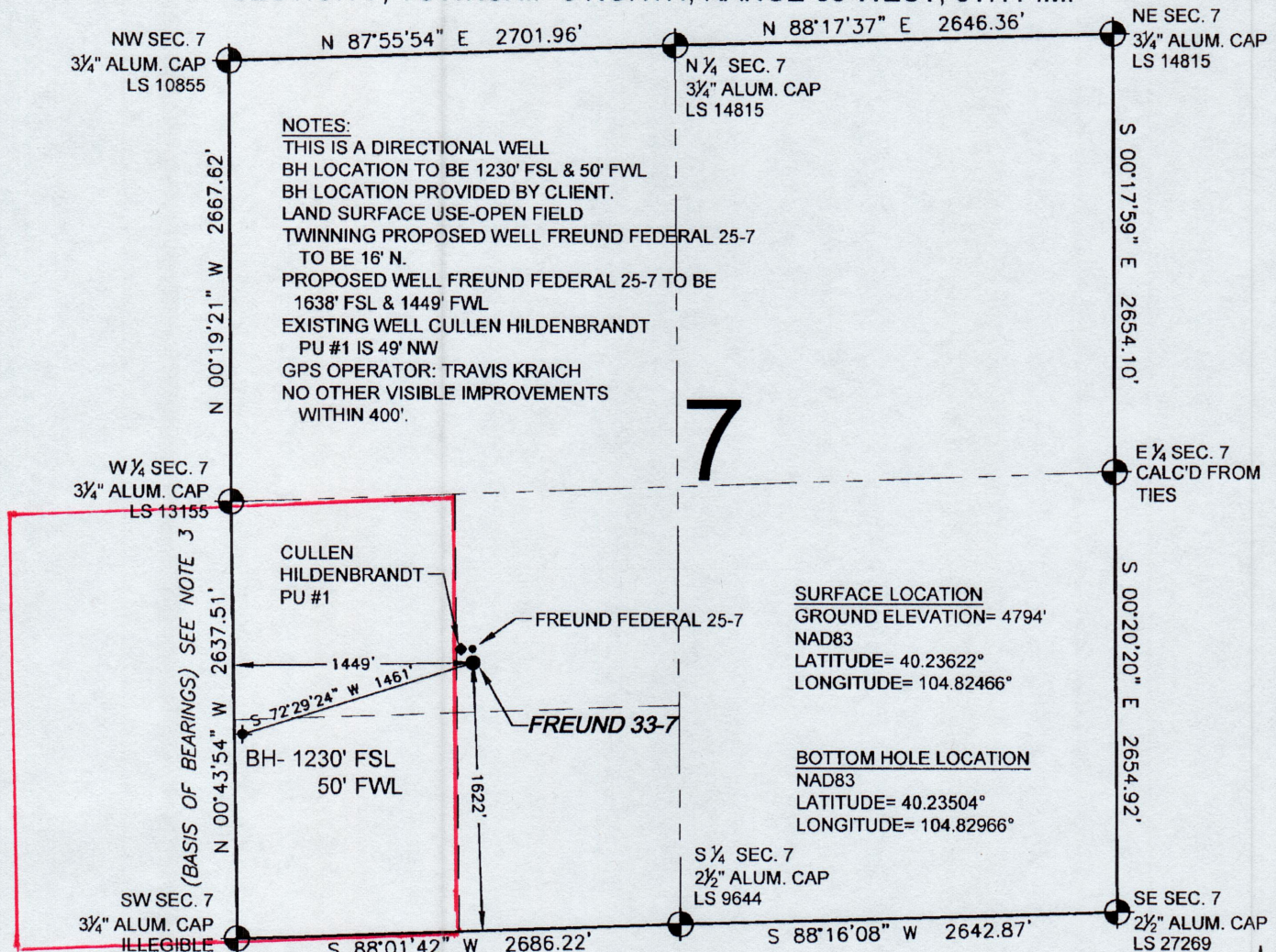

WELL LOCATION CERTIFICATE: FREUND 33-7

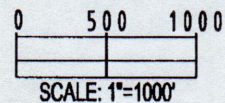
SECTION 7, TOWNSHIP 3 NORTH, RANGE 66 WEST, 6TH P.M.

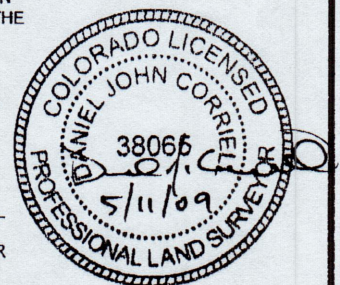

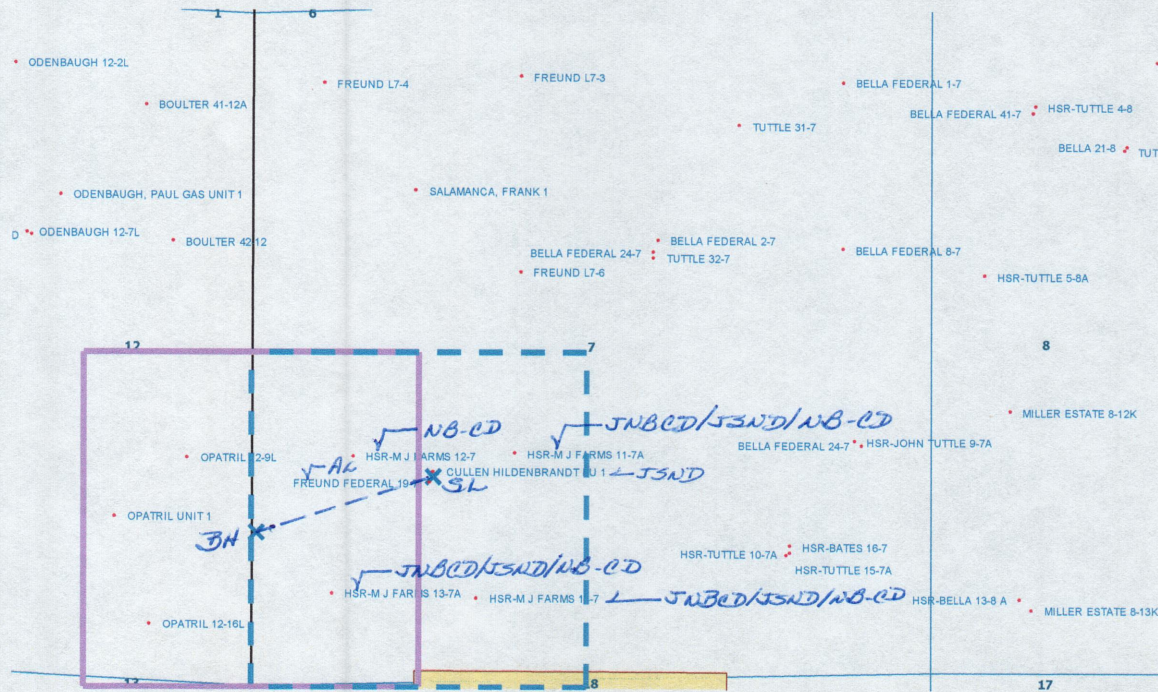
