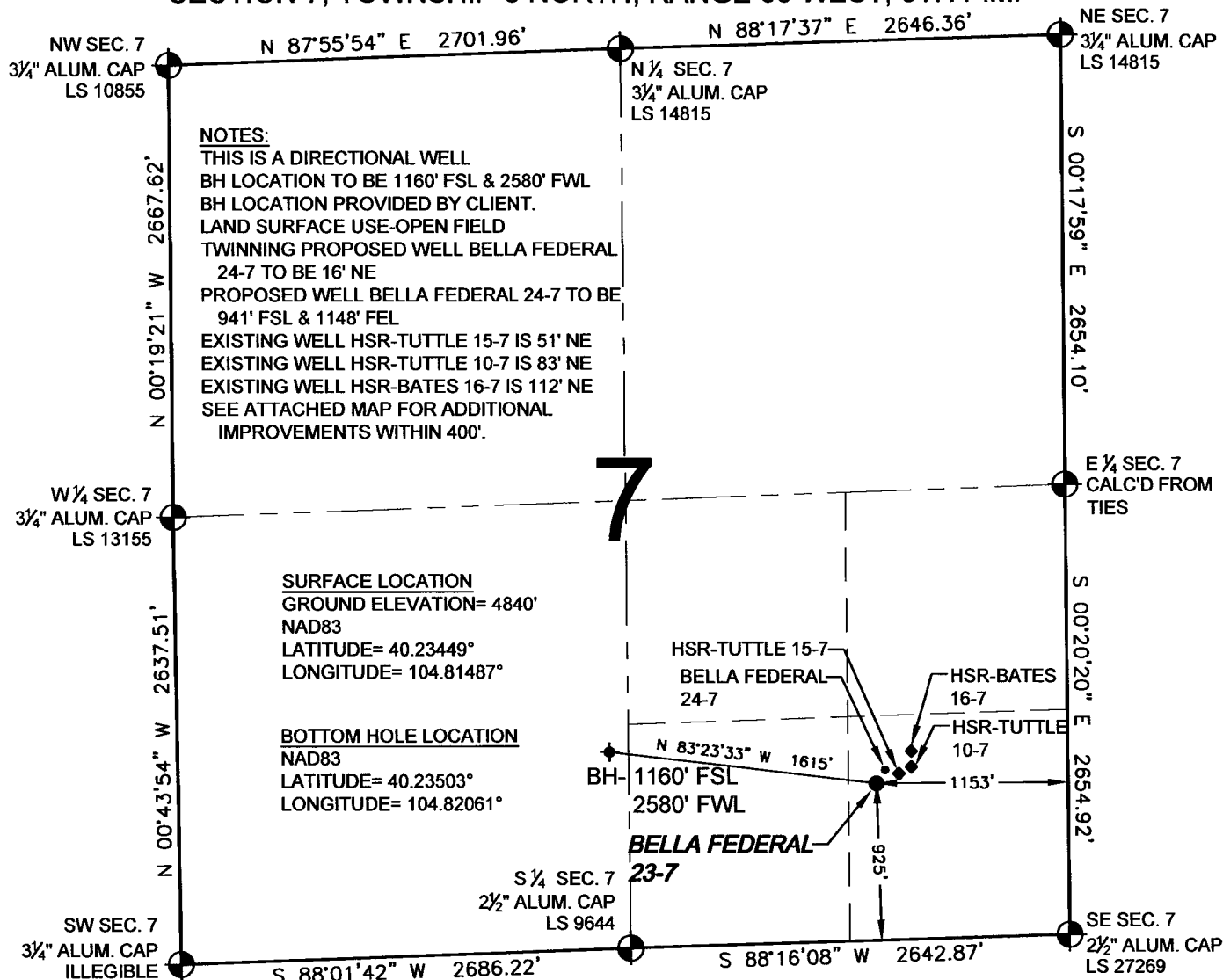


# WELL LOCATION CERTIFICATE: BELLA FEDERAL 23-7

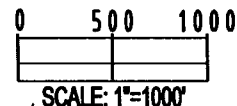
SECTION 7, TOWNSHIP 3 NORTH, RANGE 66 WEST, 6TH P.M.

● = PROPOSED WELL    ◆ = EXISTING WELL

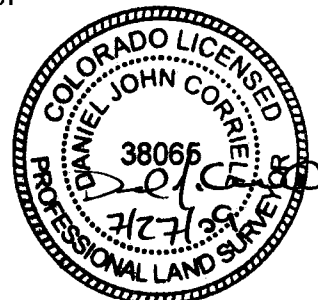

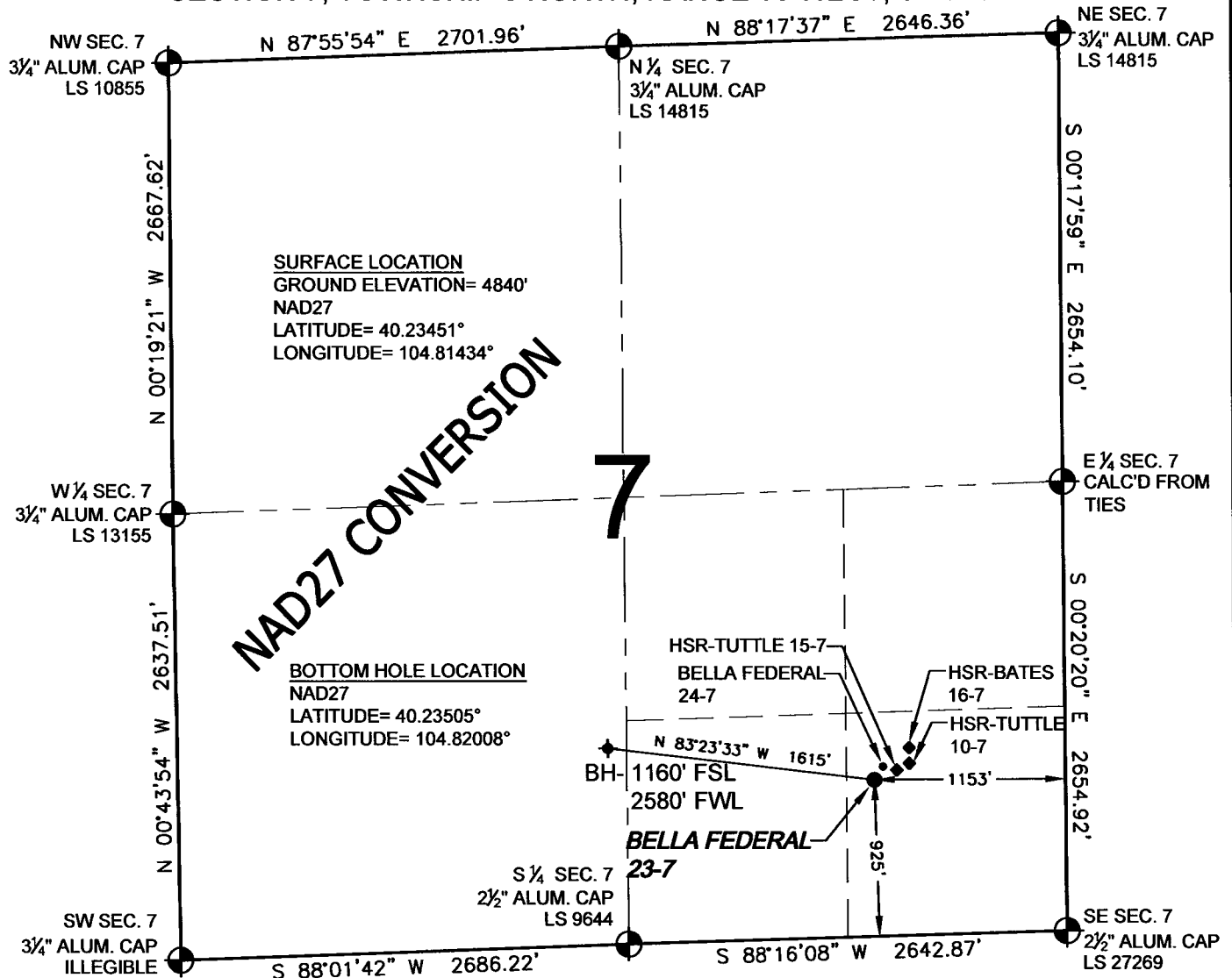

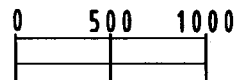
