I have been reviewing the Colorado State CC (Multi Well) 30-32D (#1757867) and Colorado State CC (Multi Well) 30-33D (#1757883) Form 2As. COGCC requests the following clarifications regarding the data Noble has submitted on or attached to the Form 2A prior to passing the Oil and Gas Location Assessment.

1. Facilities (Section 5): The facilities list should include equipment used during drilling and production both existing and to be constructed. As such, I would expect gas or diesel motors, generators, and fuel tanks might be on the equipment list. Can you please provide an updated list of existing or proposed permanent equipment for these wells (primarily stand alone equipment, not necessarily all electric, gas, or diesel motors on the drill rig itself).
2. Water Resources (Section 14): I identified the nearest surface water feature for Colorado State CC (Multi Well) 30-32D (#1757867) at 3,582 feet to the northeast and for the Colorado State CC (Multi Well) 30-33D (#1757883) at 4,506 feet to the northeast. Please let me know if you are okay with these distances and I can make the change.
