Mr. Neslin:

Noble Energy Inc. (NEI) is planning to drill the above mentioned well to the Codell/Niobrara formations

The surface location of NEI's proposed well has been staked outside of the 318Aa drilling window. The location is being permitted as an exception location. NEI has obtained written permission in a consent letter from the surface owner.

Under the Revised Rule 318A any new twinning well to be located within 50' of an existing well. The surface location of NEI's proposed well has been staked approximately 822' from the nearest oil and gas well. Noble has obtained permission, contained in a Surface Use Agreement, from the surface owner.

The surface location of NEI's proposed well has been staked at a location approximately 31' & 134'' from a surface property line. As prescribed by the Colorado Oil and Gas Conservation Commission ("COGCC") Rule 603.a.(2), Noble has obtained a waiver of said Rule 603.a.(2) from the affected surface owners. Copies of these waivers are attached for your consideration.

Thank you for your attention to the enclosed. Noble respectfully requests that the COGCC review the enclosed information and approve the requested exception location waivers and Application for Permit to Drill the captioned well.

By signing this letter you hereby grant your consent to Noble to locate the Well outside of a GWA window as defined in COGCC Rule 318A.a and waive the directional drilling requirement under Rule 318A.e. Additionally, the Well is being proposed at a surface location approximately 822 feet from an existing surface well location. By signing this letter you also grant your consent to Noble to locate the Well more than 50 feet from the existing well as provided for under COGCC Rule 318A.c.(2).

Noble hereby agrees that it will not drill the Well until you, as the Surface Owner, and Noble have entered into a Surface Use Agreement and the consideration therefore has been paid by Noble.




