Dear Messrs. Blach:

Pursuant to the Rules and Regulations of the Colorado Oil and Gas Conservation Commission ("COGCC"), Enerplus Resources (USA) Corp., as Operator, hereby gives notice to you that it intends to drill an oil and/or gas well(s) on the above-referenced lands no sooner than 30 days after the receipt of this letter.

Rule 305.e.(1).A., *Advanced Notice*, requires the Operator to provide you with the following items which are attached:

1. A copy of the Form 2A, deemed complete by the COGCC
2. A list of major equipment components to be used
3. A scaled drawing showing all visible improvements within 400 feet (Rule 303.d.(3).C)
4. An 8 ½" by 11" vicinity or topographic map showing the access road from the highway or county road providing access to the proposed oil and gas location

Please be advised that you may view the complete application, including attachments, online at the COGCC website. You may also submit comments to the Director as provided therein.

Rule 306 provides you the right to a consultation meeting, concerning the proposed operation and location of production facilities, pipelines and roads. The well location(s) will be staked before the consultation. You will be provided a plat of the proposed location and any associated roads and production facilities. We request that you indicate your consultation preference in the space provided herein.

As surface owner you have the responsibility for notifying any affected tenant of the proposed operations. You may also have the right to request that the COGCC conduct an onsite inspection with you and the Operator.
