Pursuant to Rule 305.(1).B of the Rules and Regulations of the Colorado Oil and Gas Conservation Commission ("COGCC"), Noble Energy, Inc. ("Noble") hereby gives notice to you that it intends to commence operations for the drilling of a well or wells for oil and/or gas on the referenced lands no sooner than November 6, 2009.

The attached plats illustrate the area, per COGCC rules and regulations, spacing orders or policies within which the well(s) may be located. Also the plats reflect the proposed location of the well(s) access road(s) and production facilities. The location of roads and production facilities as depicted on the plats are only proposed locations.

The location will be staked before the consultation.
