



WELL LOCATION CERTIFICATE

King Surveyors Inc. has determined the surface location of the ORR E19-06 to be 2005' from the North line and 2075' from the WEST line as measured at right angles from the section line of Section 19, Township 6 North, Range 65 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 9-2-09, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.


