Will,

I have been reviewing the Big Hole Gulch Unit #2 (#1712921) and Big Hole Gulch Unit #3 (#1712923) **Form 2As**. COGCC requests the following clarifications regarding the data Yates Petroleum Corporation has submitted on or attached to the Form 2As prior to passing the Oil and Gas Location Assessment.

1. **Water Resources (Section 14):** Form 2A indicates the depth to groundwater to be 450 feet bgs for a well located 20000 (#1712921) and 29100 (#1712923) feet away from the proposed pads. COGCC's review indicates there is a water well (Permit No. 200734-BLM, stock well) located 11352 feet to the southwest, with a total depth of 570 feet bgs and a depth to groundwater of 302 feet bgs. I can make this change if you send me an email with this request.
2. **Rule 303.d.(3).C.:** Neither the scaled construction layout drawing (Figures 1) nor the Location Drawing (Figures 4) show the location of the proposed gas and water pipelines. One or both of these drawings should show the anticipated locations of these new facilities (hand drawn estimated locations would be sufficient, or the figures you submitted to BLM).

## TYPICAL RIG LAYOUT FOR



BIG HOLE GULCH UNIT #2
