I have been reviewing the Ludwig H 06-21D Form 2A (#400008112). COGCC requests the following clarifications regarding the data Noble has submitted on or attached to the Form 2A prior to passing the Oil and Gas Location Assessment.

1. **Soils (Section 12):** Based on COGCC's review of soils at the proposed location, the following soil type came up on our GIS map: **73. Vona loamy sand, 3 to 5 percent slopes;** not 72. Vona loamy sand, 0 to 3 percent slopes. I can make this change and add the soil description to the attachments if you send me an email with this request.
