If the reference area is adjacent to the proposed pad and vegetation can be seen on the location pictures, then a reference area map and the four (each of the cardinal directions) color photographs taken during the growing season are not needed. I need you to send me an email stating that the reference area is either adjacent to the pad (if that is the case), and in which direction from the pad the reference area lies; or that the reference area is not adjacent to the proposed pad and the location needs to shown on the map (in which case, EnCana has 12 months to submit reference areas pictures).
