Michael,

The time frames you have below will be difficult for our operations to work around. We propose the following language which has been acceptable to the CDOW on other locations such as the PI15 Pad.

In a good faith effort we will conduct post-development well site visitations between the hours of 9:00 a.m. and 4:00 p.m. and reduce well site visitations between December 1 and April 15 in elk winter concentration areas. On the occasion that well conditions are not stabilized we will need to continue working past 4:00 p.m. **This BMP is to exclude fluid movement in order to protect the environment.**

Please let me know if this BMP language is ok with EnCana. I would like to make our recommendation to COGCC as soon as possible.

Thanks for meeting with CDOW this morning at the proposed well pad site. As we discussed at the site, CDOW would like to add the following BMP to the list of BMPs that you submitted in your Form 2A Surface Location Assessment. The proposed language is:

EnCana and subcontractors will make a good faith effort to conduct post-development well site visitations to between the hours of 10:00 a.m. and 3:00 p.m. and reduce well site visitations between December 1 and April 15 in mule deer critical winter range.

Please let me know if this language is agreeable to you, if it is please let me and Dave Kubeczko know so that it will be included in your 2A application.

Thanks again for your cooperation and willingness to work with the CDOW.
