At this time, DOE does not request any additional information but would encourage COGCC to place general language in the permit such that the company would accommodate DOE sampling requests in the future. DOE agrees with the COGCC assessment that the pad is located approximately

2.6 miles from the Rulison site on an existing pad located at NESE Section 15 7S 95W, and the bottom-hole-locations range approximately from 2.3 to 2.7 miles from Project Rulison. Accordingly, DOE agrees with COGCC that all wells fall under the Tier 2 sampling and monitoring of the COGCC Rulison Sample and Analysis Plan and are located in Sector 11 of the Rulison SAP. DOE will continue to review the proposed locations and subsurface orientations of the propose drilling for documentation when sampling occurs. 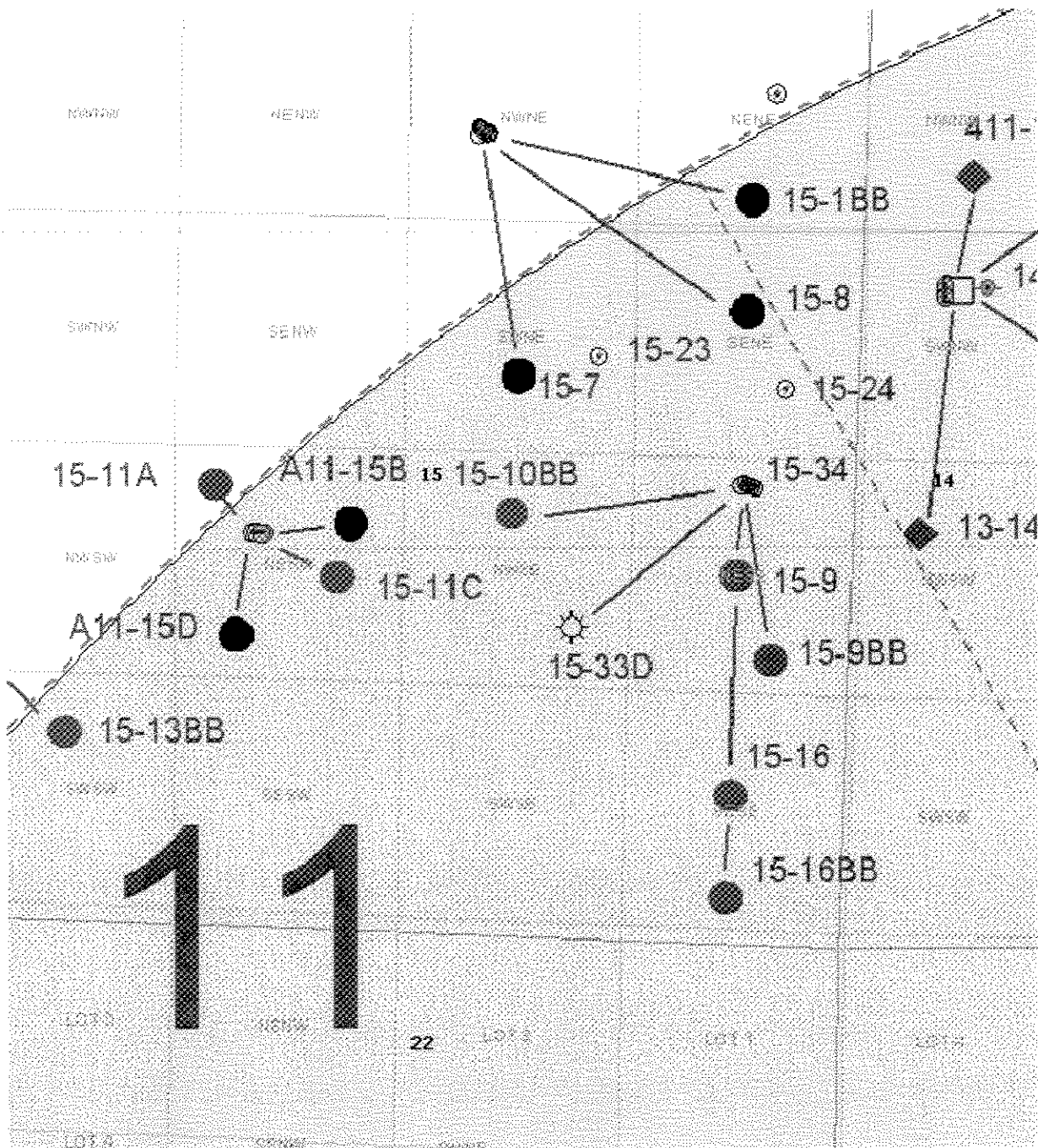

Encana has submitted refile permit applications for 5 wells located on an existing pad NESE Section 15 7S 95W. The pad is approximately 2.6 miles from the project well. The BHLs are approximately 2.3 to 2.7 miles from the project well. They are all Tier 2 wells in Sector 11 of the Project Rulison SAP. The well list spread sheet is attached.
