Location is in a sensitive area because of soil type (Gulnare) and potential impacts to GW; therefore, operator must ensure 110 percent secondary containment for any volume of fluids contained at well site during drilling and completion operations.

Operator must implement best management practices to contain any unintentional release of fluids.
