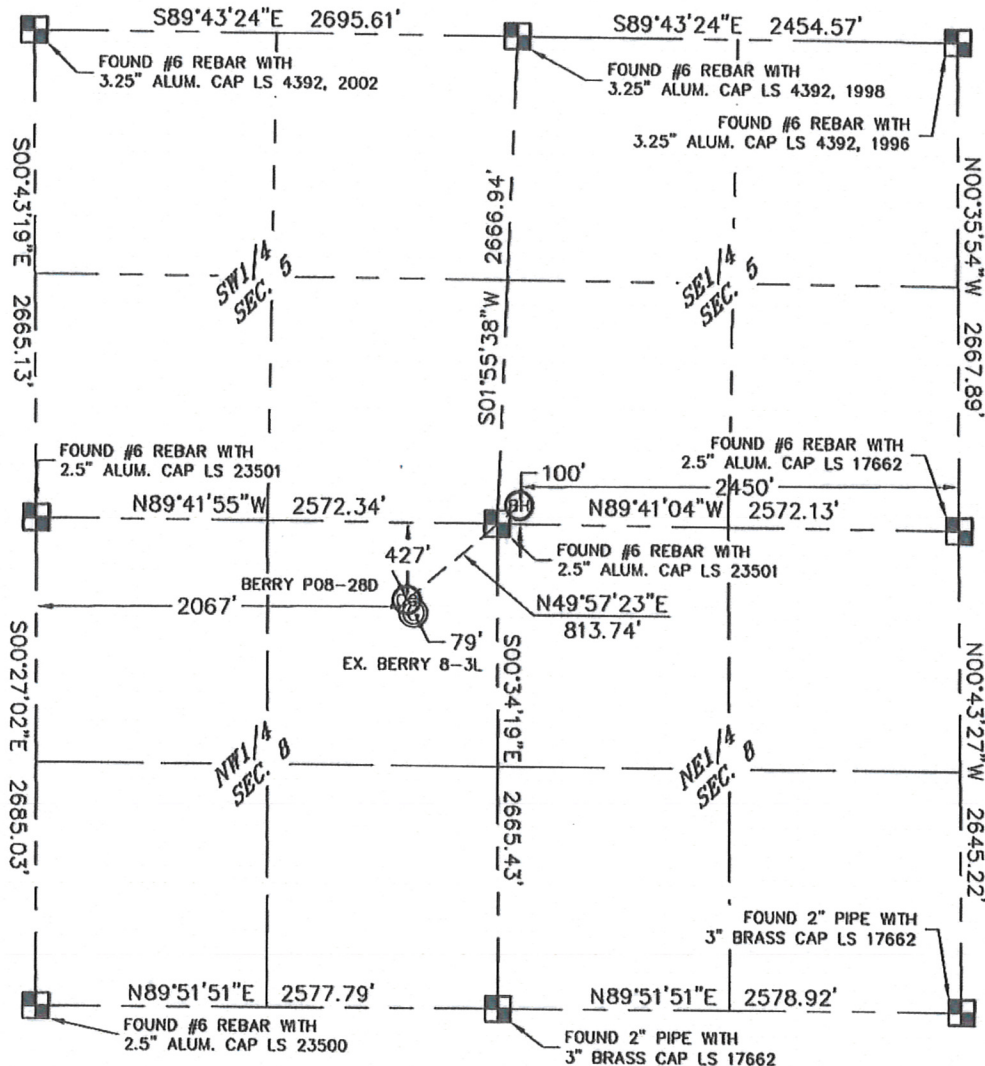

King Surveyors Inc. has determined the surface location of the Berry P08-28D to be 427' from the North line and 2067' from the West as measured at right angles from the section line of Section 8, and the bottom hole to be 100' from the South line and 2450' from the East line from the section line of Section 5, Township 3 North, Range 67 West of the Sixth Principal Meridian, County of Weld, State of Colorado. I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 7-29-09, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plot or an Improvement Survey Plot, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.

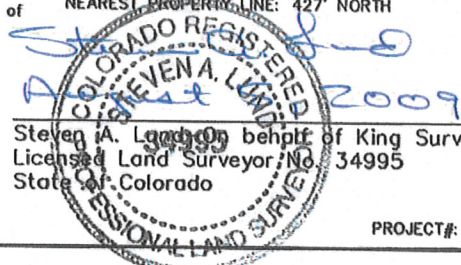

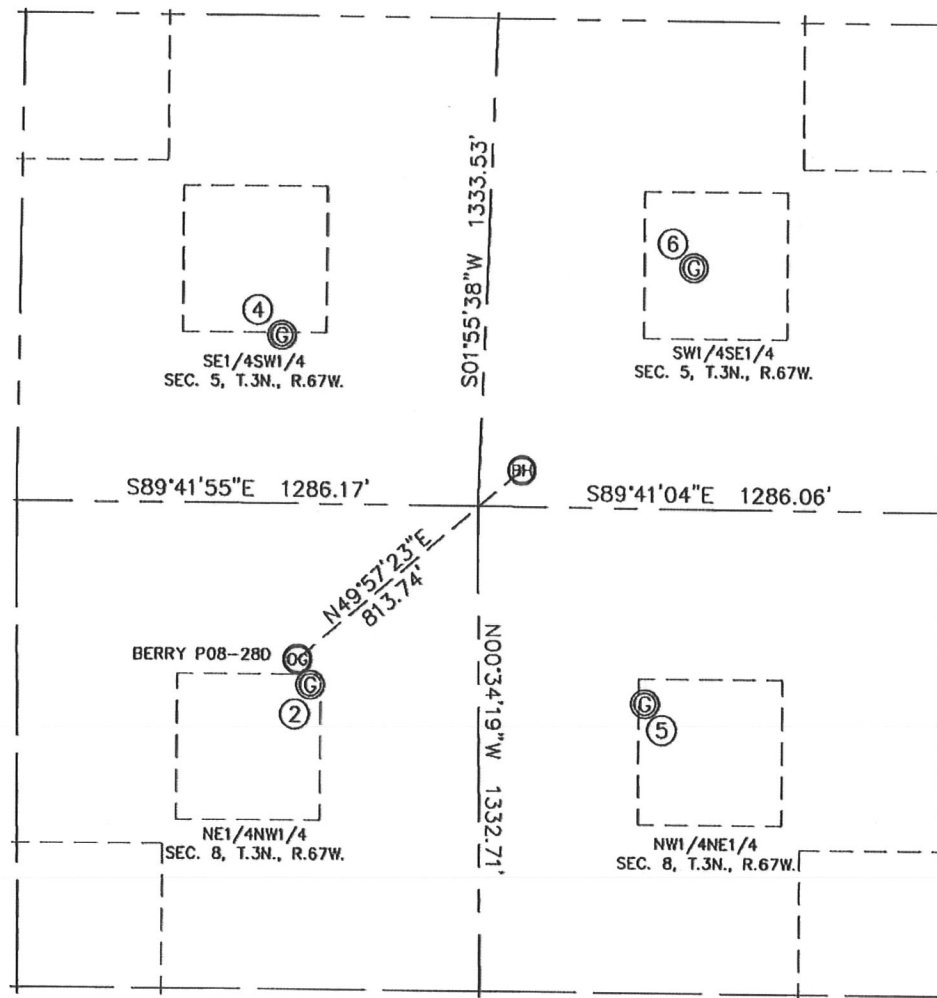
