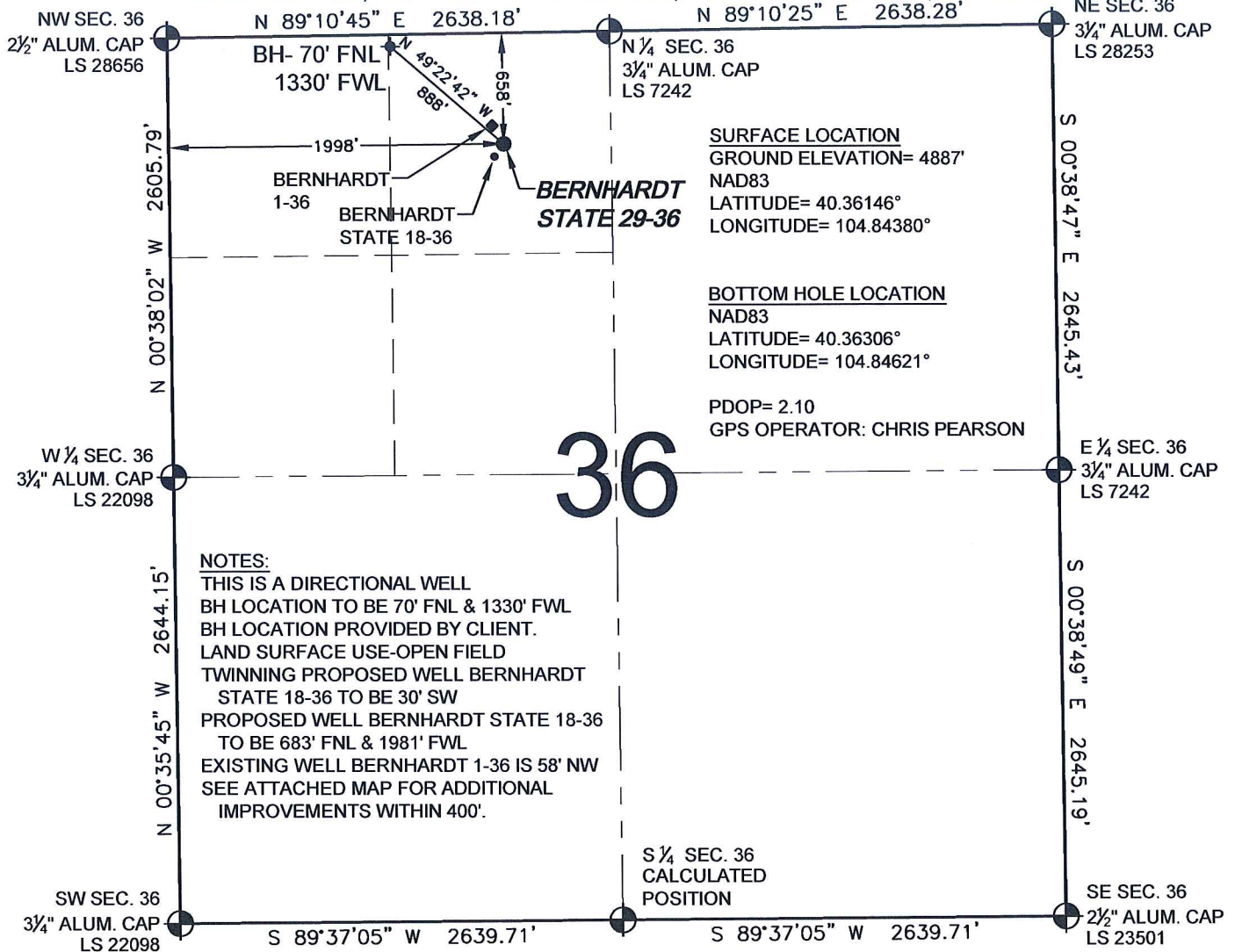






# WELL LOCATION CERTIFICATE: BERNHARDT STATE 29-36

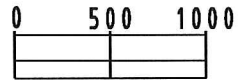

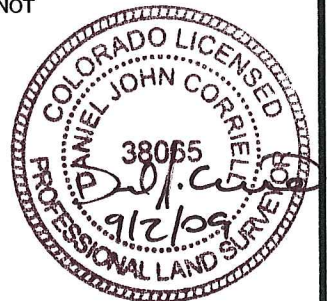

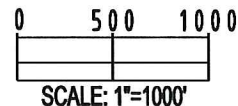
