

MEMORANDUM OF SURFACE USE AGREEMENT

WHEREAS on the 23rd day of July, 2009, Binder Family Farms LLC, whose address is 9783 WCR 46.5, Milliken, Colorado 80543, hereinafter referred to as "Owner" entered into a Surface Use Agreement (hereinafter the "Agreement") with Unioil, a wholly owned subsidiary of Petroleum Development Corporation, whose address is 1775 Sherman Street, Suite 3000, Denver, Colorado 80203, hereinafter referred to as "Company," covering and affecting property with the legal description identified as the following ("Property"):
