Water well receipt 43660A. Well will be tied into a common tank battery called the "Wells Ranch State 28 NE/4 Tank Battery". A separate 2A has been submitted. No depth to water data is available for the nearest water well. The depth to groundwater of 15 feet was taken from the nearest water well with data (permit #13197) approximately 6,388 feet from proposed location, and there appears to be approximately 78' of elevation gain from the water well to the proposed location. Future land use reference area will be immediately adjacent to the location as indicated in the "north" photograph.
