Miracle,

I have been reviewing the GMR 8-6 (K8W) **Form 2A** (#400021153). COGCC requests the following clarifications regarding the data EnCana Oil & Gas has submitted on or attached to the Form 2A prior to passing the Oil and Gas Location Assessment.

1. **Water Resources (Section 14):** Form 2A indicates the depth to groundwater to be 320 feet bgs for a well located 4884 from the proposed well. COGCC's review indicates there is a water well (Permit No. 26833-MH-Canders, other/monitoring well) to the east-northeast, with a total depth of 320 feet bgs, a depth to groundwater of 100 feet bgs, and a pumping rate of 10 gpm. I believe this is the well you located. The number that comes up on our GIS map is 320 feet (this number often pertains to the total depth of the well, not the depth to groundwater). I can make the change if you send me an email with this request.

This issue is very minor, but needs to be addressed prior to getting this permit passed. If you have any questions, please do not hesitate to call me at (970) 625-2497 x5 (office) or (970) 309-2514 (cell), or email. Thanks.
