

MEMORANDUM OF
SURFACE USE AGREEMENT

WHEREAS on the 17 day of December, 2009, the undersigned, Kathleen Carter, whose address is 27 N Driver Ct. Pagosa Springs, CO 81447, hereinafter referred to as "Owner" entered into Surface Use Agreement, hereinafter the "Agreement", with Rosetta Resources Operating LP, whose address is 1200 17th Street, Suite 700, Denver, Colorado, 80202, hereinafter referred to as "Operator", covering and affecting property with the legal description more particularly described as follows:

Section 17: N½ Less and except the following parcels:
