This well is on same pad as existing Wardell 18-13J and proposed Wardell H 19-30D. Depth to ground water determined by using static water level data of nearest water well found on COGCC map (Permit #26851/Receipt #9063252), however please note that this water well was not located upon visual inspection. The surface water distance is based on stream found on COGCC map, however stream not found upon visual inspection. The nearest railroad is over 1 mile from proposed location. The reference area is on undisturbed ground immediately adjacent to the west of the location as shown in the "west" location photograph.
