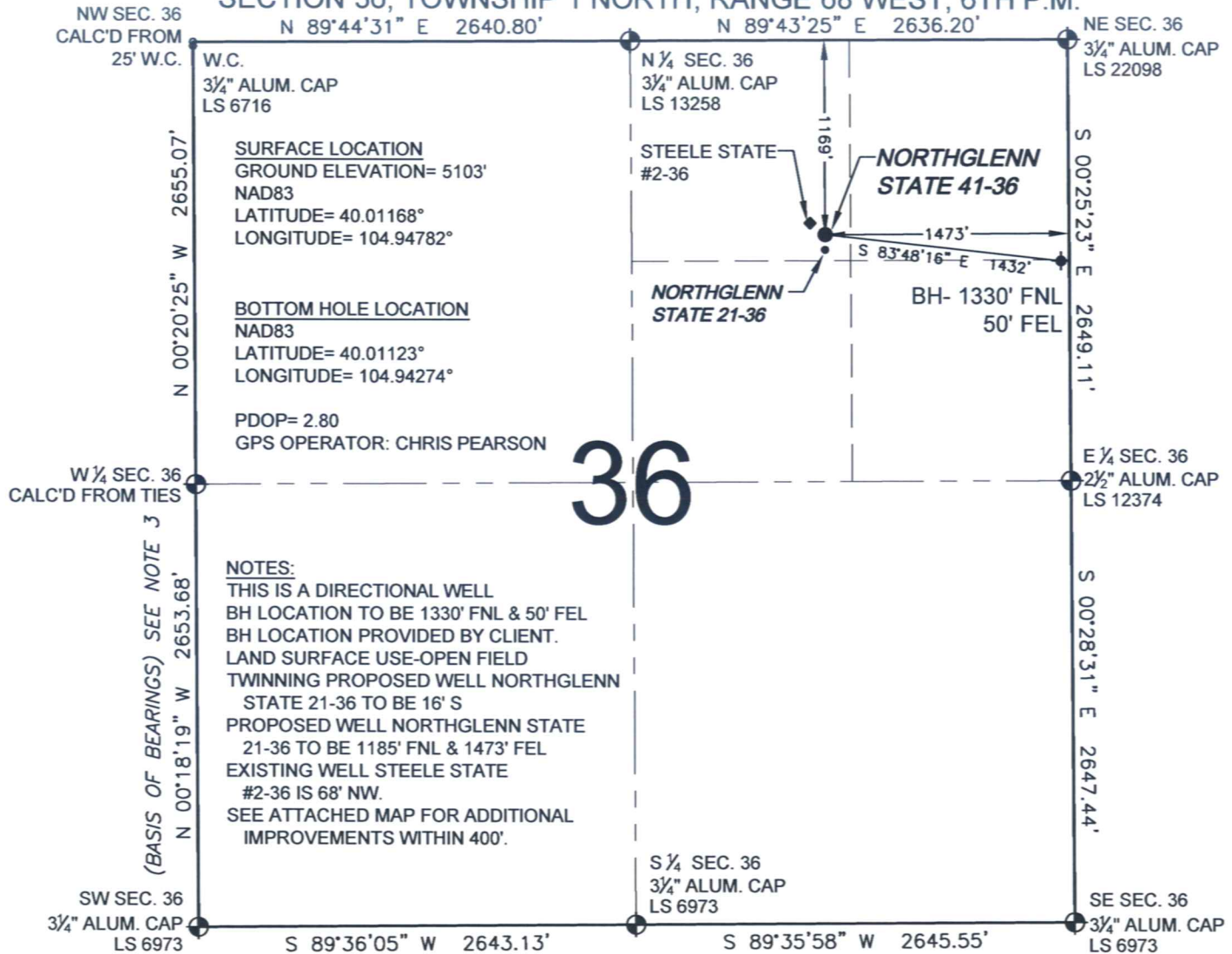




WELL LOCATION CERTIFICATE: NORTHGLENN STATE 41-36

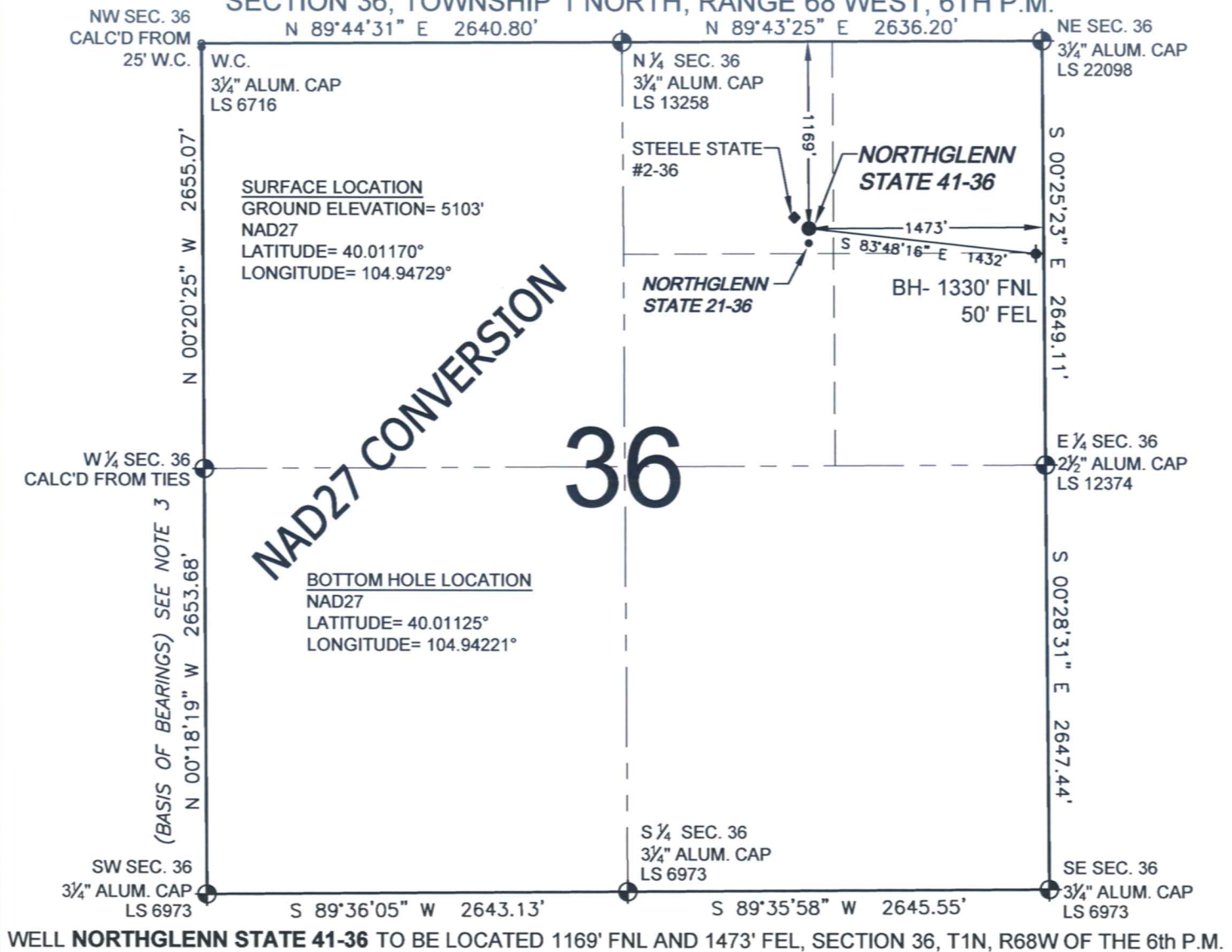

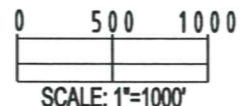
