The nearest water well depth to ground water was taken from [www.dwr.state.co.us/wellviewweb-](http://www.dwr.state.co.us/wellviewweb-) receipt #9070143, permit #67014. The Distance to nearest surface water was measured to the North Fork Black Wolf Creek (510' away). The Surveyor confirmed that this creek is currently dry. The next nearest surface water is greater than 1 mile away. The full Surface Owner Name should read Brent C. Deterding & Brad W. Deterding. The surface owner waived the 306 consultation on 11/22/2009. Reference area pictures will be submitted at a later date. This is a previously permitted location but since the pad has not been built yet, we are submitting this Form 2A as part of the Re-file process under the new rules.
