SPECIAL PRECAUTIONS ARE BEING TAKEN TO PREVENT ANY WATER FLOWS, EXTRA FLOW BACK VOLUME IS PLANNED ON LOCATION IN THE FORM OF FRAC TANKS TO CONTAIN ANY WATER FLOWS UNTIL THEY CAN BE CONTROLLED AND TO CONTROL FLOWS DURING DRILLING OF THE WELL BORE UNTIL CASING CAN BE SET.
