Linda...I think all of his 'site specific' suggestions are fine: (I modified a few)

In a good faith effort Noble Energy or subcontractor will conduct post-development well site visitations between the hours of 9:00 a.m. and 4:00 p.m. and reduce well site visitations between May 15 and June 15 in elk production areas. On the occasion that well conditions are not stabilized Noble can to continue to work past 4:00 p.m. (This is not a timing restriction for activities between May 15-June 15)

Control weeds in areas surrounding reclamation areas in order to reduce weed competition.

Avoid aggressive non-native grasses and shrubs in elk habitat restoration.

Reclaim elk habitats with native shrubs, grasses, and forbs appropriate to the ecological site disturbed when possible and available.

I also attached the BMP chart I was going to use for the CDP.

Subject Battlement Mesa 34-33B Well Pad

Linda,

I have reviewed the Battlement Mesa 34-33B Well Pad Form 2A permit and ask that you submit a list of BMPs for wildlife protection, specifically BMPs related to elk production areas.

I am including a "pick list" of BMPs that will help you get started with the BMPs that will work best for you and the surface owner. There is a section on deer and elk. Please select the ones that you can implement and create a list to submit to COGCC and copy me. The COGCC contact person is Dave.Kubeczko@state.co.us

I am also including several "site specific" BMPs that relate directly to elk production that may be beneficial to you as well.

Site Specific Suggested BMPs.

In a good faith effort Noble Energy or subcontractor will conduct post-development well site visitations between the hours of 9:00 a.m. and 4:00 p.m. and reduce well site visitations between May 15 and June 15 in elk production areas. On the occasion that well conditions are not stabilized Noble can to

continue to work past 4:00 p.m.

Control weeds in areas surrounding reclamation areas in order to reduce weed competition.

Avoid aggressive non-native grasses and shrubs in elk habitat restoration.

Reclaim elk habitats with native shrubs, grasses, and forbs appropriate to the ecological site disturbed.

Restore appropriate sagebrush species or subspecies on disturbed sagebrush sites. Use locally collected seed for reseeding where possible.

Please let me know if you have questions or would like clarification on any of the BMPs.
