The nearest building, public road, railroad, above ground utility and surface water are all over 1 mile from proposed location. The depth to ground water determined by using static water level data of 3rd closest water well (Permit #62466/Receipt#9064975) because there was no static water level data for closest well. The reference area is on undisturbed ground immediately adjacent to the location to the East as shown in the East location photo. Please note that this location was previously permitted under the old rules but since this pad has not been built yet we are submitting a Form 2A as part of the re-file process under the new rules.
