
Ladies/Gentlemen:

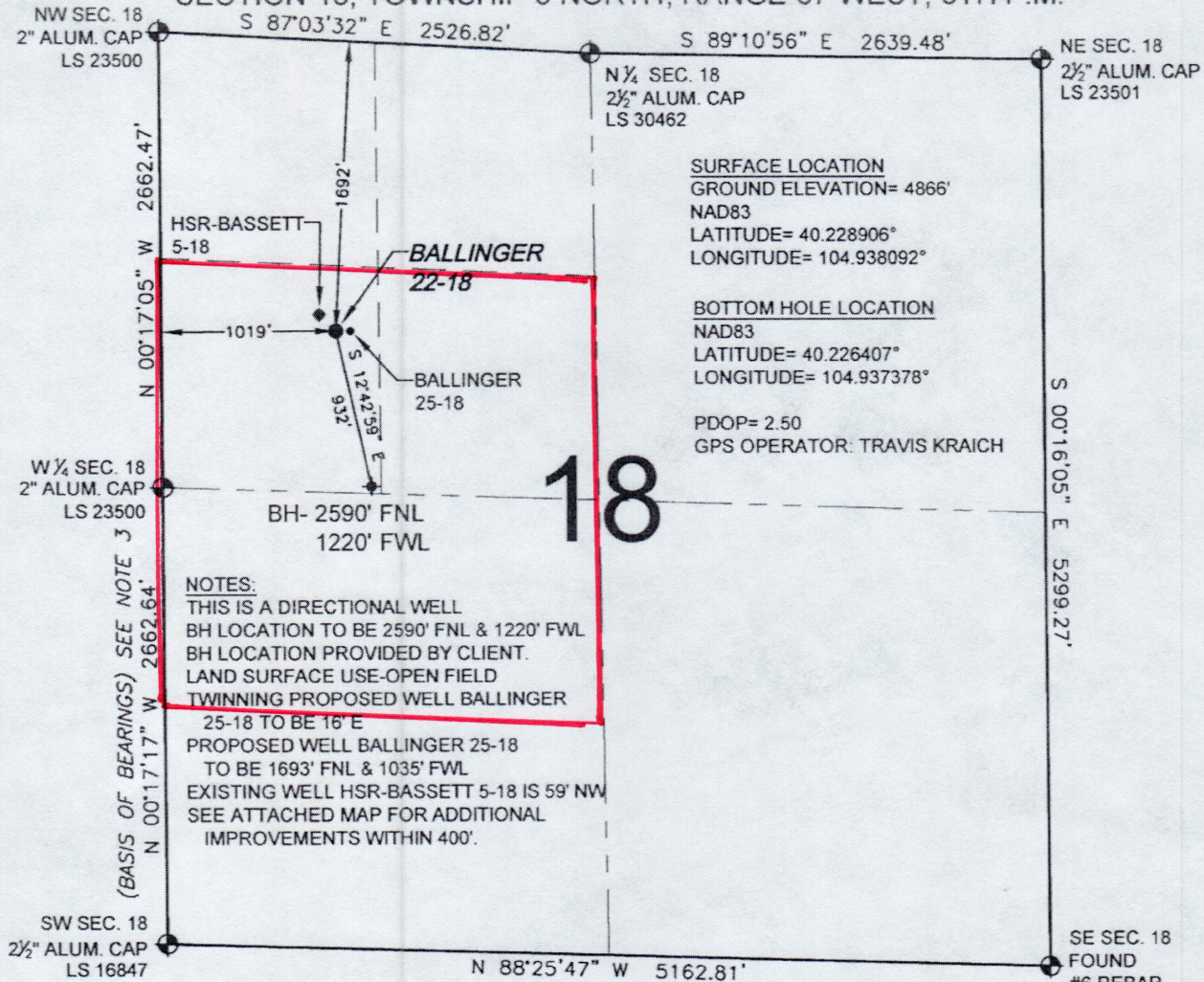

WELL LOCATION CERTIFICATE: BALLINGER 22-18

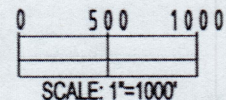

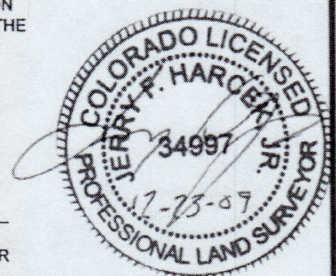

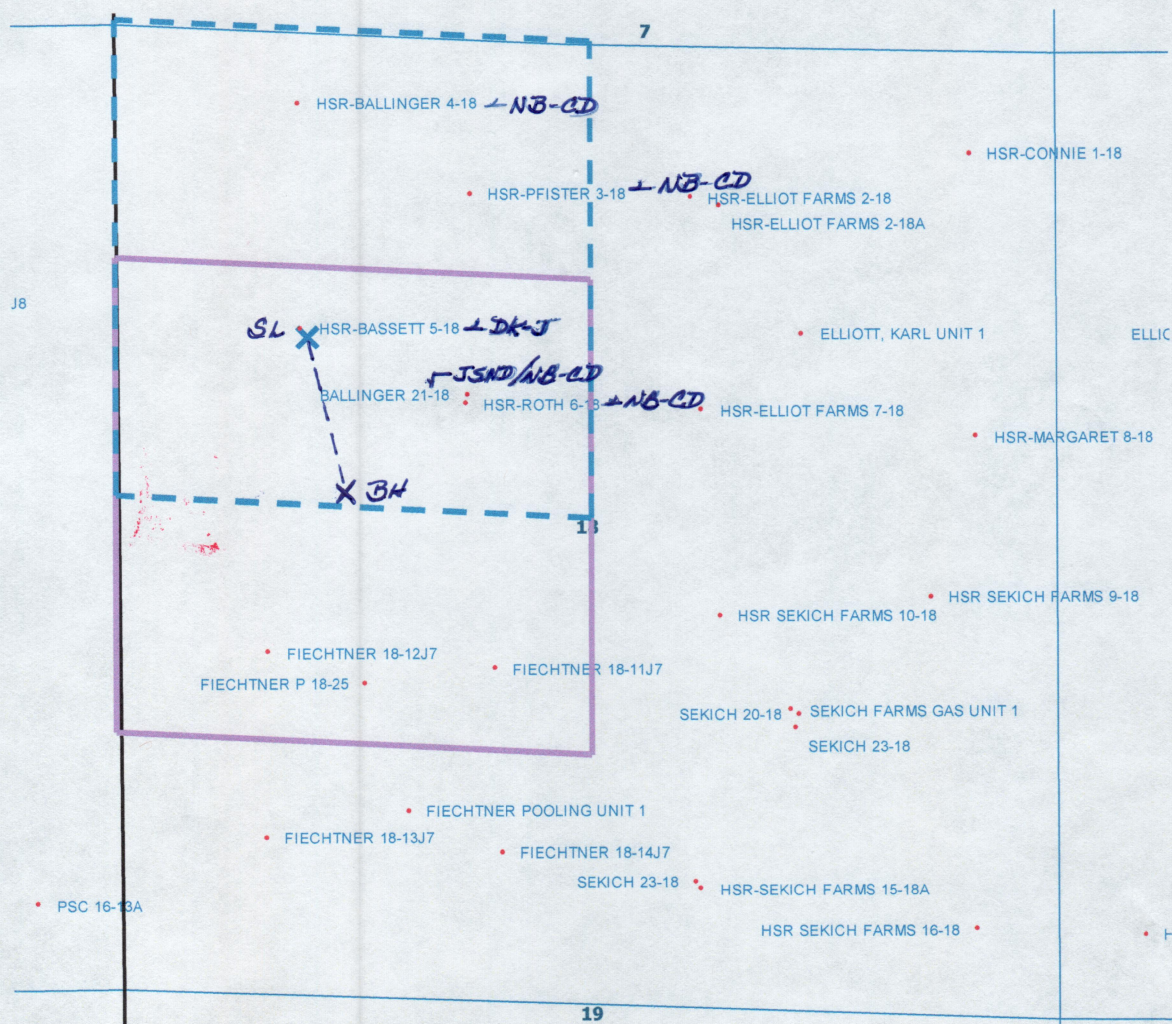
