Attached is the CBL that was run after the first brhd squeeze attempt on the Couey 24-10B (F24W). We pumped the second squeeze job yesterday with perf holes at 3720'. We had 0 psi on the bradenhead the entire time the job was pumped, and had 0 psi this morning with no fluid. We feel the pressure has been squeezed off and the remediation was successful. A water sample was collected prior to the squeeze job and we have contacted our service company to send in the results. I will forward them on to you as I receive them.
