The reference area is undisturbed ground immediately adjacent and to the South of the pad, as shown in the South location photo. This is a previously permitted location but since the pad has not been built yet, we are submitting this Form 2A as part of the Re-file process under the new rules. Location is in a sensitive area due to being within the Northern High Plains Designated Basin.
