



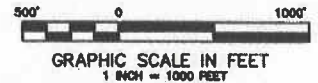

INFORMATION

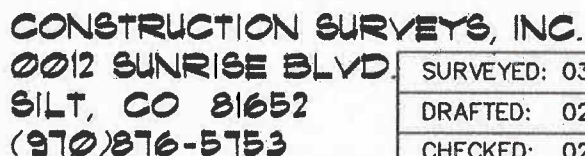
CALCULATED BOTTOM

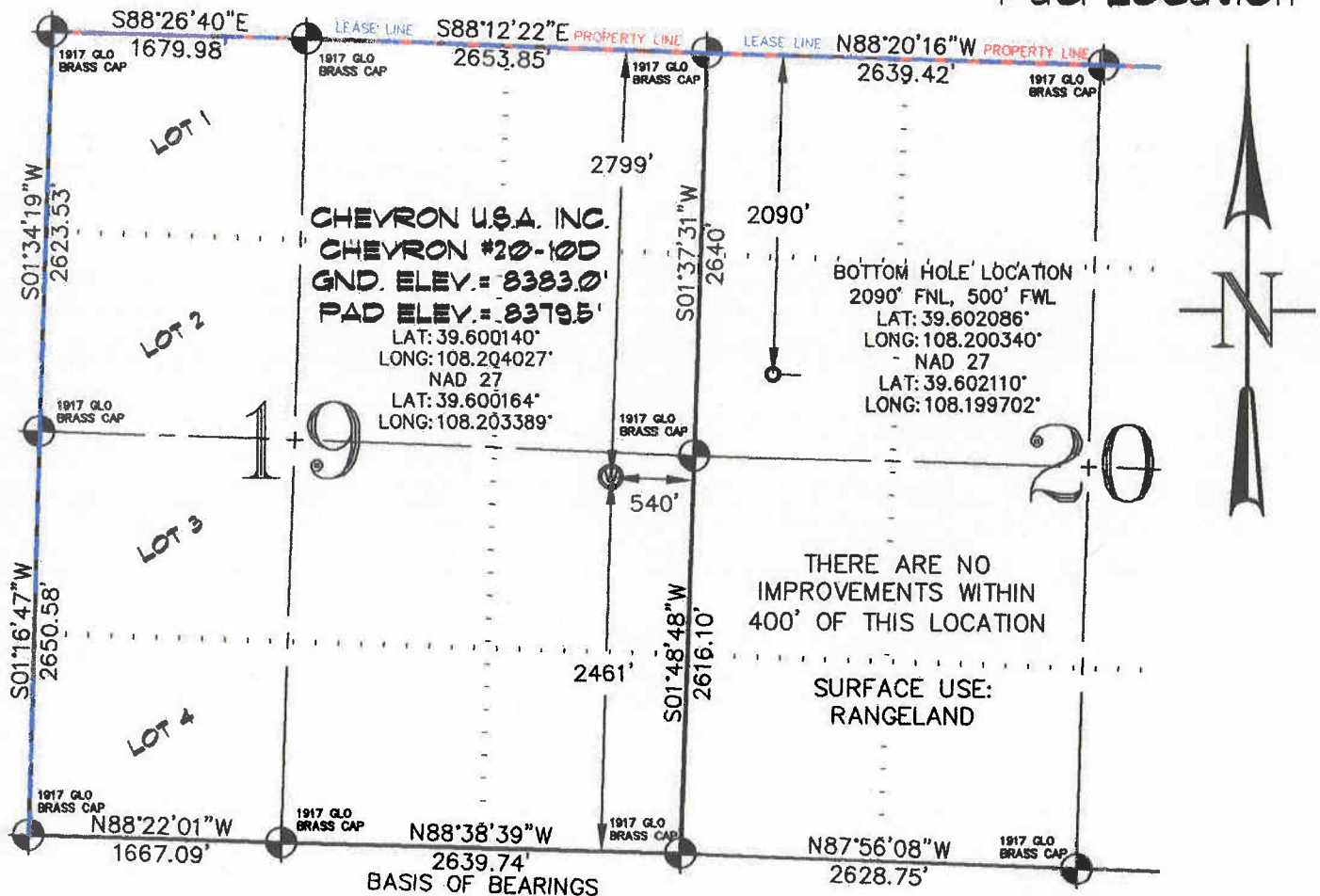

Pad Location



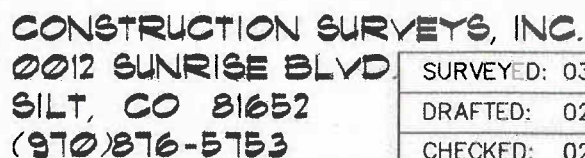

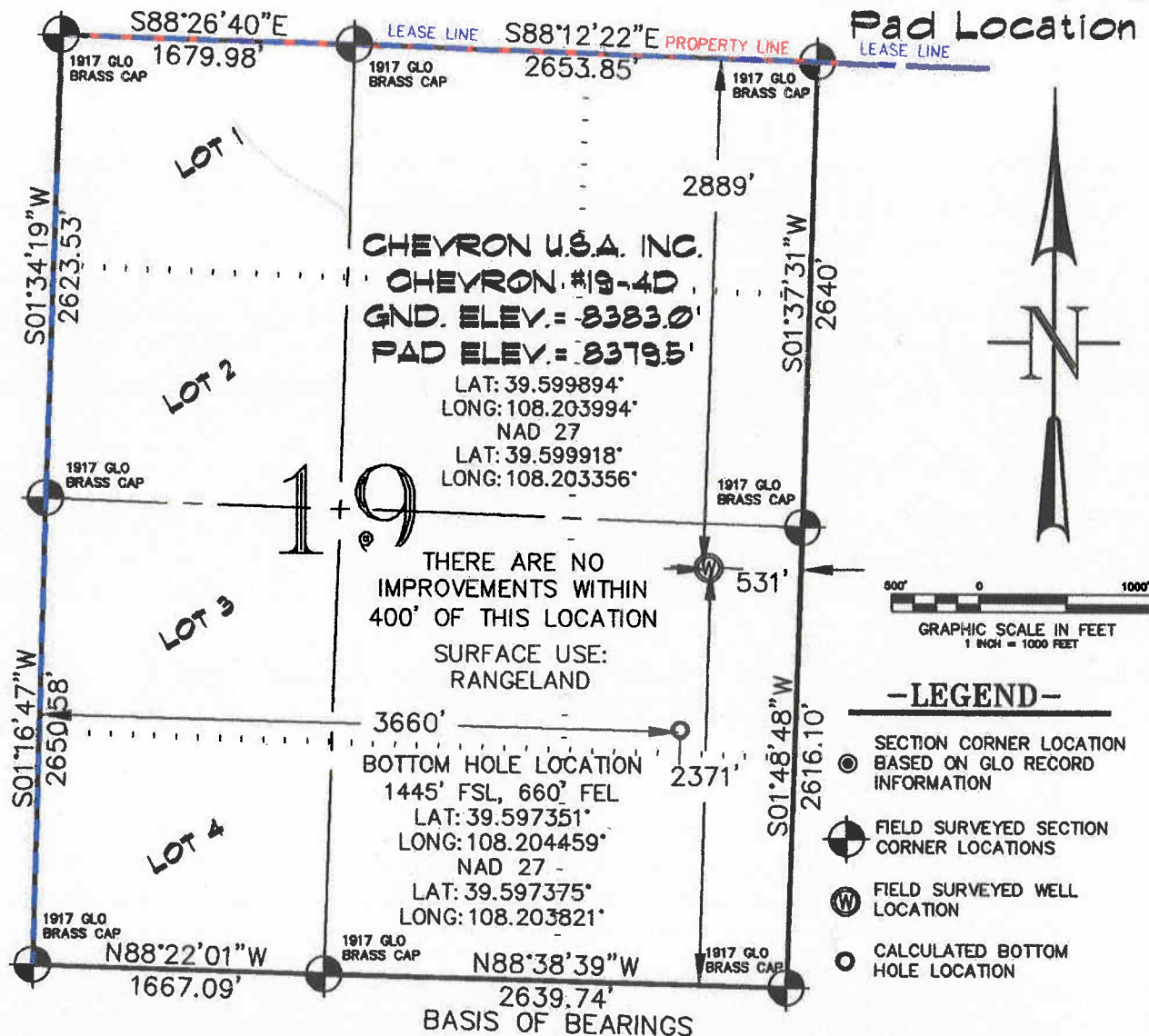
