33. Comments Cement will be circulated to the surface in the Conductor String. Cement will be circulated to 200' above the uppermost Mesaverde sand in the Production String. The Pad has been built. The pits have been constructed. There was no Pad expansion needed. There is not a Rig on location. This location does not require a variance. Williams has executed a Memorandum of Understanding (MOU) with the CDOW and BLM which sets forth commitments for the protection of wintering Mule Deer while year round drilling takes place within a concentrated area of northeast Ryan Gulch. Also associated with this MOU is a Wildlife Mitigation Plan currently being reviewed by the CDOW which will further guide activity in this part of the Ryan Gulch field. It is anticipated the WMP will be finalized in March or April of 2010.
