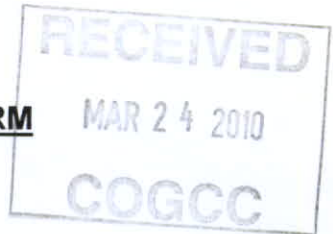

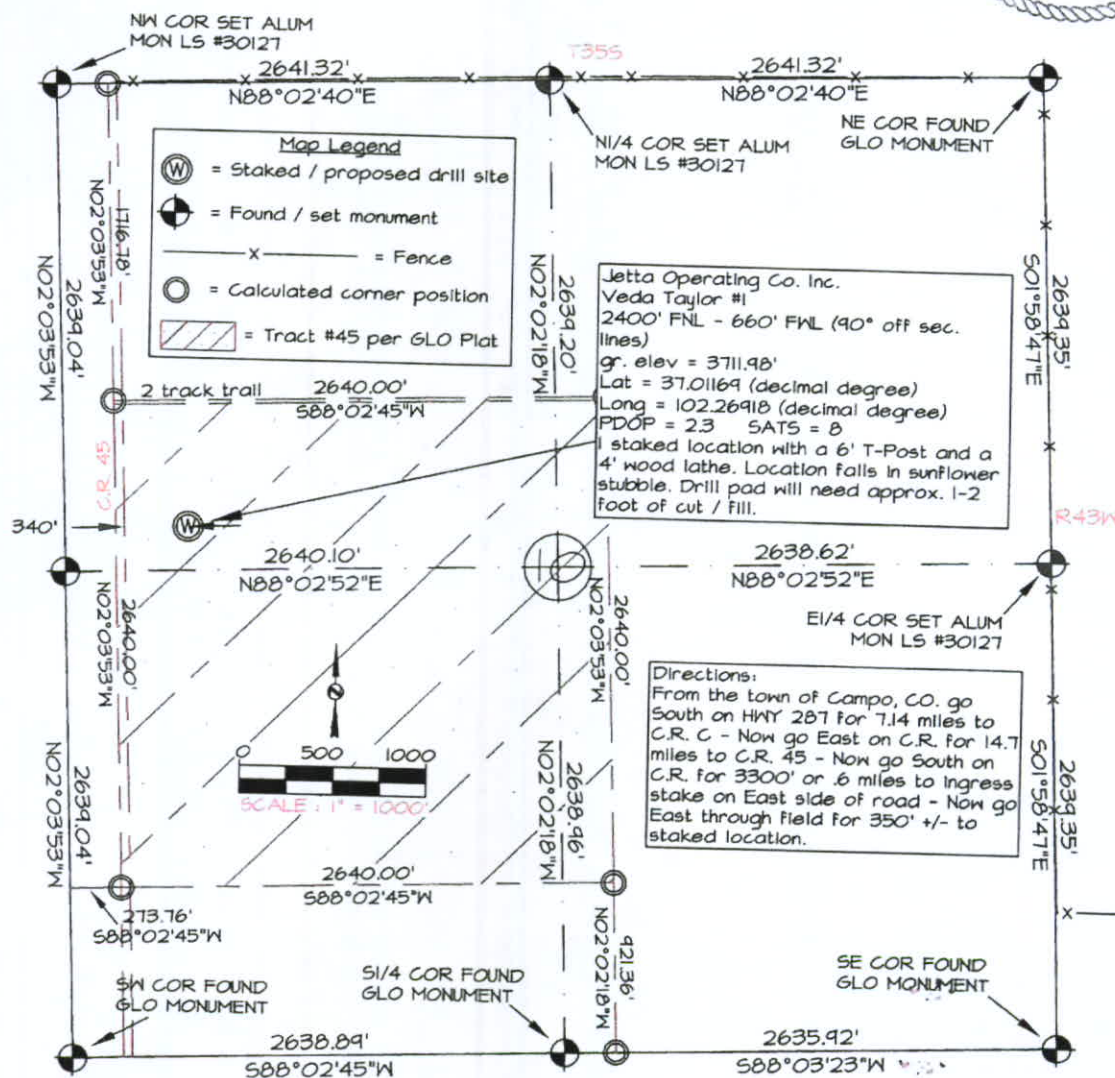

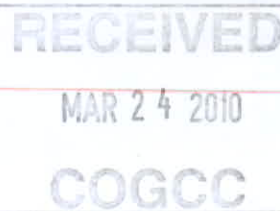
## WELL LOCATION MAP
