There will be no conductor pipe used in the construction of this well bore as the intermittent irrigation pond will be dry when the growing season is over (when KPK rig 1 would drill this location) and the nearest domestic water well is over 1900 feet away. Ongoing discussion with regard to SDA or SUA with surface owner and will be submitted when complete. Until that time, KPK will bond on to drill this well. The only improvements within 400' of this proposed location are agricultural improvements (irrigation ponds, irrigator and water pipe for the irrigator) as well as the agricultural road/lease road already in existence for the offset well (Camenisch #41-32, API# 05-123-24569). This is an exception location and waivers are attached to the Form 2. Page 2 of Camenisch #7-32-25R, location #306388, form 2A.
