Pursuant to Rule 305 of the Colorado Oil and Gas Conservation Commission (COGCC) Rules and Regulations, Rosetta Resources Operating LP, as Operator, hereby gives notice to you that it intends to commence operations for the drilling of a well or wells on the above referenced lands no sooner than (30) days from the date of this notice.

As surface owner, you have the responsibility for notifying any affected tenant of the proposed operations. In addition, you may have the right to request that the COGCC conduct an onsite inspection with you and Rosetta Resources. Also, in accordance with Rule 306, you have the right to a consultation concerning the proposed operations. A consultation page is enclosed to indicate your preference. Please note: the well location(s) will be staked before the consultation.
