Jevin,

I have been reviewing the HC Federal 25-22-45-15 **Form 2A** (#2585947). COGCC requests the following clarifications regarding the data EnCana Oil & Gas has submitted on or attached to the Form 2A prior to passing the Oil and Gas Location Assessment (OGLA).

1. **Rule 303.d.(3).F.ii.aa and bb:** Since the current and future land uses are non crop land (rangeland), a reference area needs to be indicated either on a topographic map or in the comments section if the reference area is adjacent to the proposed pad. In addition, four (each of the cardinal directions) color photographs taken during the growing season of the reference area are required within 12 months of the Form 2A permit application date (03/15/2010) unless the reference area is adjacent to the proposed pad and vegetation can be seen on the location pictures. The preconstruction location pictures submitted as reference area pictures cannot be used since the reference area selected needs to remain undisturbed. Therefore, a reference area map and additional reference area photos will be required.

COGCC would appreciate your addressing this issue with the Form 2A permit prior to passing the OGLA review.
