ACCORDING TO THE CO DIVISION OF WATER RESOURCE WEBSITE THE NEAREST WATER WELL, PERMIT #42713, IS 113' AWAY. THE WEBSITE SHOWS ANOTHER WELL, PERMIT #42713-A, APPROXIMATELY 400' TO THE NE, WITH A STATUS UNKNOWN BUT OUR SURVEYOR SAID THERE ARE NO WATER WELLS WITHIN THE 400' RADIUS. ACCORDING TO OUR SURVEYOR THE NEAREST WATER WELL IS 407' TO THE NE AS SHOWN ON OUR LOCATION DRAWING. THE WELLS WILL FLOW TO THE EXISTING BATTERY NEAR THE DAVIS GAS UNIT #1, LOCATED APPROXIMATELY 930; TO THE NW.
