Since this location is in a sensitive wildlife habitat area, Antero contacted CDOW prior to submittal of this application to consult with them concerning wildlife mitigation. We have implemented the BMP's that they suggested in our attached list of proposed BMP's. The depth to ground water was determined by using the static water level data of nearest water well (Permit #196178/Receipt# 0401073). A riparian map is attached which shows that the proposed well pad is not located in a riparian area. Our reference area is undisturbed ground immediately adjacent and to the South of our proposed well pad, as shown in the "south" location photo; Reference area photos to be taken in growing season.
