The full surface owner name should read Marion L. Chapman & Hazel I. Chapman. This location is in a sensitive area due to the coincidence with the Northern High Plains Designated Groundwater Basin. This well will be producing to a water tank on another wells' location which will not require expansion of the ground disturbance. There will be no separator or VOC combustor on location. Noble requests waiver to Rule 318B; well location is less than 300' from outer boundary of said quarter section; the subject well will encroach on the SW quarter of Sec. 33, 1S-R44W at a distance of 230'.
