The railroad is 2.32 miles +/- from site. There are no visible improvements within 400'. The nearest water well 2355 +/- feet from site (RECEIPT: 9053977; PERMIT: 61502; USE: DOMESTIC STOCK). There is an ephemeral stream located 645 +/- feet southwesterly of location. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COAs are needed for this location.

A Pump Jack 'maybe' necessary to place on facility in the future to help with gas production. It will require either one gas or one electric motor to run the pumping jack unit, which will be determined at the time its installed.
