No conductor pipe used to construct this well. There is a current SUA with amendments attached to form 2. Power line 3409' to the west. There are no domestic/irrigation water wells for at least a three mile radius, several groundwater monitoring wells in area. Farmer's Extension Ditch is approximately 3660 to the southwest. Well will offset McCarty #2, API#05-123-10514, per multi-well pad plan, associated tank battery facility located in center of SE/4 section 21 will have separate 2A filed. Battery will service eight wells: McCarty #2, #10-21, #10-21-23, #10-21-24, #15-21-37, #20-21, #20-21-9, and #20-21-16.
