Nearest Surface water, is closer to 1700 ft, the feature on the topo map, is very old and no longer holds water. Closest Water well is actually 1752' and is owned by CDC (Colorado Dept of Corrections) depth is ~720', no static water level is given, which is why the next closest well with actual water level data is 4527' feet away from well site. Rail road is greater the 1 Mile away. Reference area is located adjacent to and on undisturbed ground to the north of the location. Location picture is reference area picture. Surface Owner is State of Colorado, Department of Corrections, Division of Correctional Industries. (Well is within State Correctional grounds. Inspectors must call ahead for appointment.) Location is on land where slope is less than 10% per Tim Engel via phone call JLV.
