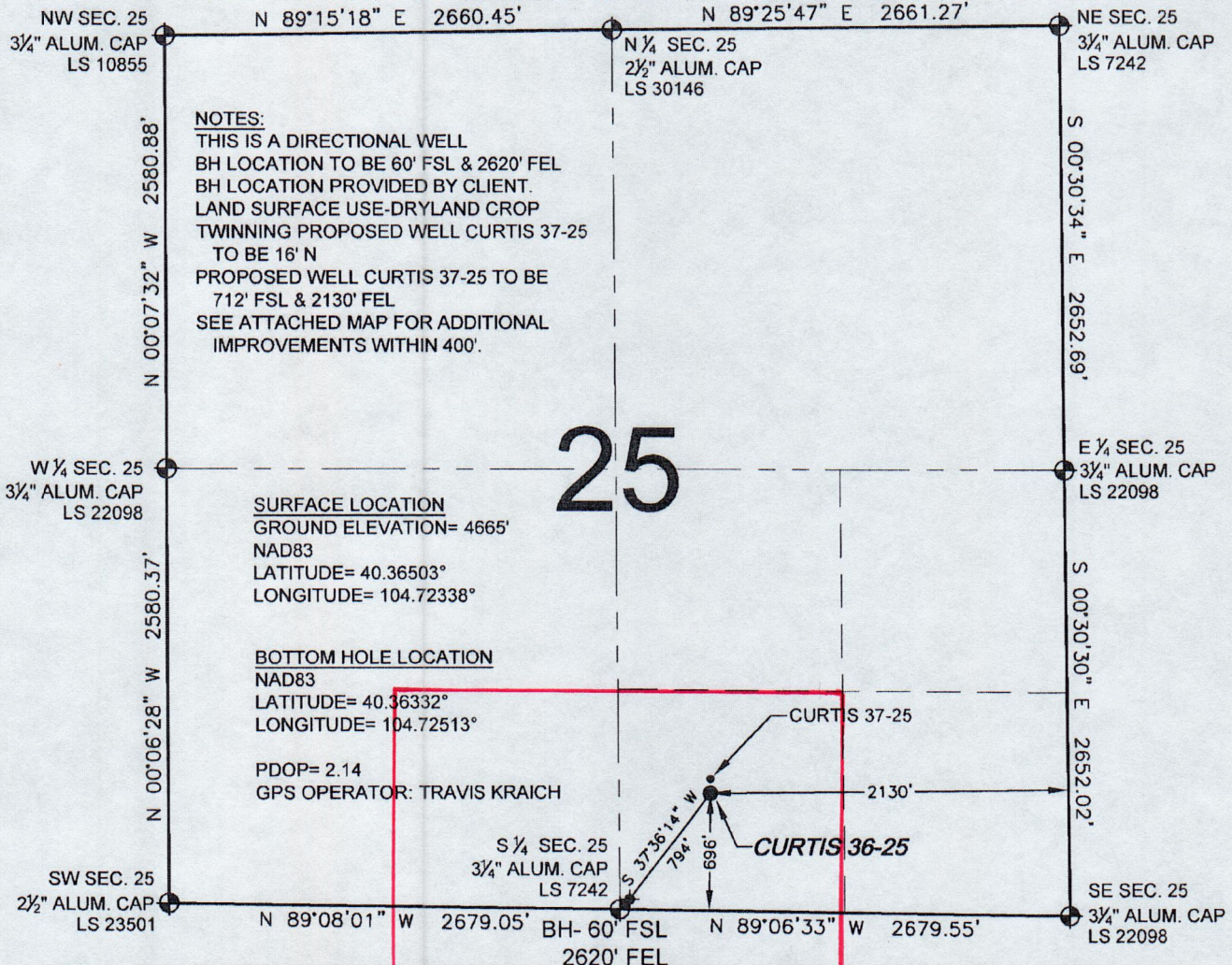

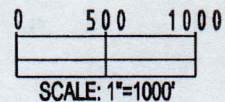
# WELL LOCATION CERTIFICATE: CURTIS 36-25

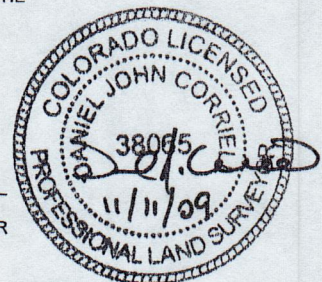

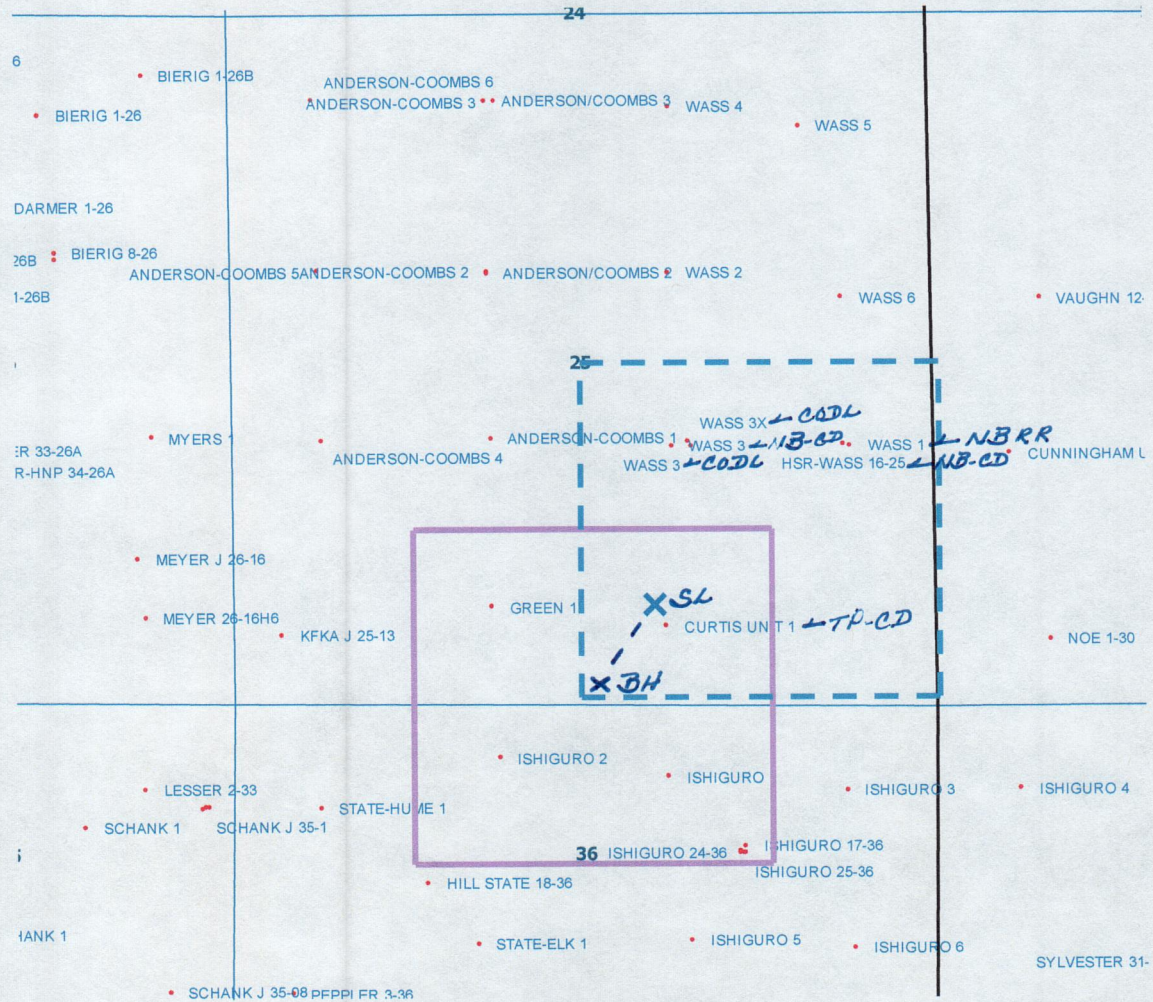
