


FIGURE 3. REGIONAL PROJECT LOCATION MAP.



LEGAL DESCRIPTION

TOWNSHIP 27 SOUTH, RANGE 65 WEST OF THE 6TH P.M.

Section 31: SW $\frac{1}{4}$ NW $\frac{1}{4}$; NE $\frac{1}{4}$ SW $\frac{1}{4}$; that part of NE $\frac{1}{4}$ NW $\frac{1}{4}$ lying South of Highway No. 10; that part of NW $\frac{1}{4}$ NE $\frac{1}{4}$ described as, beginning at the Northwest corner of said NW $\frac{1}{4}$ NE $\frac{1}{4}$; thence East 300 feet; thence South 1053 feet; thence West 300 feet; thence North 1053 feet more or less, to the point of beginning.

TOWNSHIP 27 SOUTH, RANGE 66 WEST OF THE 6TH P.M.
