RAILROAD IS OVER 2 MILES FROM THE SITE. NEAREST WATER WELL IS 4288 FEET, MORE OR LESS, FROM SITE. PERMIT #61502; RECEIPT 9053977. THIS LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. THERE IS AN EPHEMERAL STREAM APPROXIMATELY 755+/- FEET NORTHEASTERLY OF SITE. A PUMP JACK MAYBE NECESSARY TO PLACE ON FACILITY IN THE FUTURE TO HELP WITH GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR TO RUN THE PUMPING JACK UNIT WHICH WILL BE DETERMINED AT THE TIME OF INSTALLATION.
