Casing plan – Production casing top of cement will be > 500' above top of gas.

Delta Petroleum is the surface owner, therefore Rule 306 is not applicable. There will not be a 30 day letter or SUA attached.

I certify that all conditions in the original permit are the same, except for distance to property line, which has been updated since Delta became surface owner. There have been no changes to land use or well construction. Pad BCU 14L is an existing pad. Pad expansion is required, COGCC Form 2A is including in permit package.
