Dear Mr. Kelly:

The Colorado Oil and Gas Conservation Commission (COGCC) has specific guidelines and procedures regarding surface activities. These rules stipulate an operator must give an affected surface owner notice in writing at least thirty (30) days prior to drilling an oil and gas well.

It is Slawson Exploration Company Inc.'s intention to begin operations to drill 30 oil and gas wells located on state lands (see list of wells attached). Slawson may drill the wells thirty (30) days from this date or sooner if your approval to waive the thirty day notice requirement is given below. It is your responsibility to notify the tenant farmer, if applicable, of this proposed operation.

- * A brochure describing surface owner rights and responsibility
- * the policies for a consultation with Slawson (COGCC Rule 306)
