

**3<sup>rd</sup> AMENDMENT OF  
SURFACE USE AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, under the date of September 23, 2004, **ExxonMobil Oil Corporation** ("Surface Owner") and **Williams Production RMT Company** ("Operator"), with Surface Owner and Operator collectively called the "Parties," did execute a Surface Use Agreement (the "Agreement"), recorded in Book 1642, Page 778 of the official records of Garfield County; and,

WHEREAS, under the date September 11, 2006, **ExxonMobil Oil Corporation**, ("Surface Owner") and **Williams Production RMT Company** ("Operator") did execute an Amendment of the Surface Use Agreement (the "Amendment"); and,

WHEREAS, under the date December 4, 2008, **ExxonMobil Oil Corporation**, ("Surface Owner") and **Williams Production RMT Company** ("Operator") did execute a 2<sup>nd</sup> Amendment of the Surface Use Agreement (the "2<sup>nd</sup> Amendment"), reception number 761655 of the official records of Garfield County; and,

WHEREAS, the Agreement provided for the use of the surface estate to drill, equip and operate the proposed wells ("Wells") to be located in Section 27 of Township 6 South, Range 96 West, 6<sup>th</sup> P.M., and further described in the "Agreement"; and,

WHEREAS, it is the desire of the "Parties" to execute a 3<sup>rd</sup> Amendment to the Surface Use Agreement ("3<sup>rd</sup> Amendment") by amending Exhibit "C" to accurately reflect changes and additions made to existing and proposed wells.

NOW, THEREFORE, in consideration of the good and valuable consideration, the receipt and adequacy of which are hereby acknowledged by the "Parties" hereto, it is agreed:

The "Parties" agree to amend Exhibit "C" of the "Agreement". All other terms and conditions of the "Agreement" and subsequent Amendments remain unaltered and are in full force and effect as of the date hereof.

This 3<sup>rd</sup> Amendment of Surface Use Agreement shall be binding on any and all successors and assigns of the "Parties".

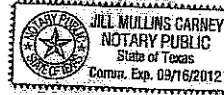

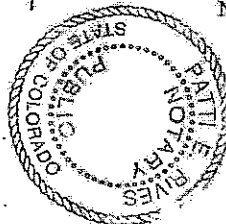
