Dear Mr. and Mrs. Kirchenschlager,

Per COGCC rule 318c, we would like to request an exception location waiver for the drilling of the above referenced well. The proposed well falls under WLR 318B which requires the location to be 300 feet from a lease line and 300' from a section line. The proposed location will be approximately 50' east of your 6.65 acre lease in the NW/4 of said section. Therefore we are encroaching on the lease in which you are a mineral holder of record. There are fault planes to the north and east of the proposed location as well as to the southwest. We have moved this location approximately 250 north of the original permitted location. We feel this new location will provide better amplitude as well as porosity and permeability.

Please acknowledge your acceptance of this Exception Location Waiver by signing below within fifteen (15) days from receipt of this letter and return in the enclosed self-addressed stamped envelope. A map is enclosed showing the approximate location of the well to your lease line.
