This location was abandoned on Berry Petroleum's behalf, but Augustus Energy purchased Berry Petroleum 04/01/09 and Augustus would like to refile this location using the existing API #05-125-11415-00. A change of operator has also been submitted (3/05/10) changing the location from Berry to Augustus. All conditions remain the same.
