No depth to groundwater is available for the nearest water well. Permit #243503 was used for depth to ground water. Well will be tied into a common tank battery at the Wells Ranch 36D location. A new 2A will be filed if necessary for the tank battery. The final use reference area is immediately adjacent to the location as indicated in the "east" photo, and growing season photos are materially the same as the photos on the Wells Ranch State 28C location.
